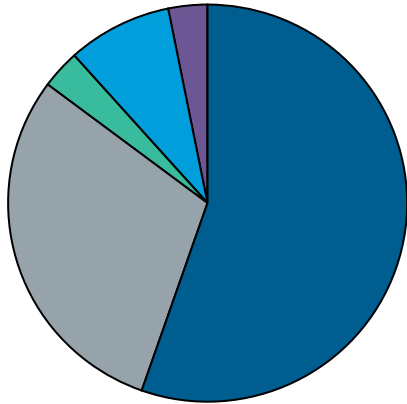
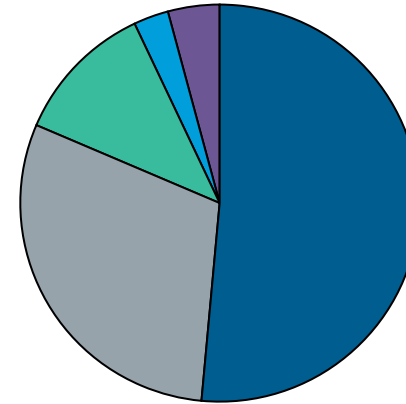

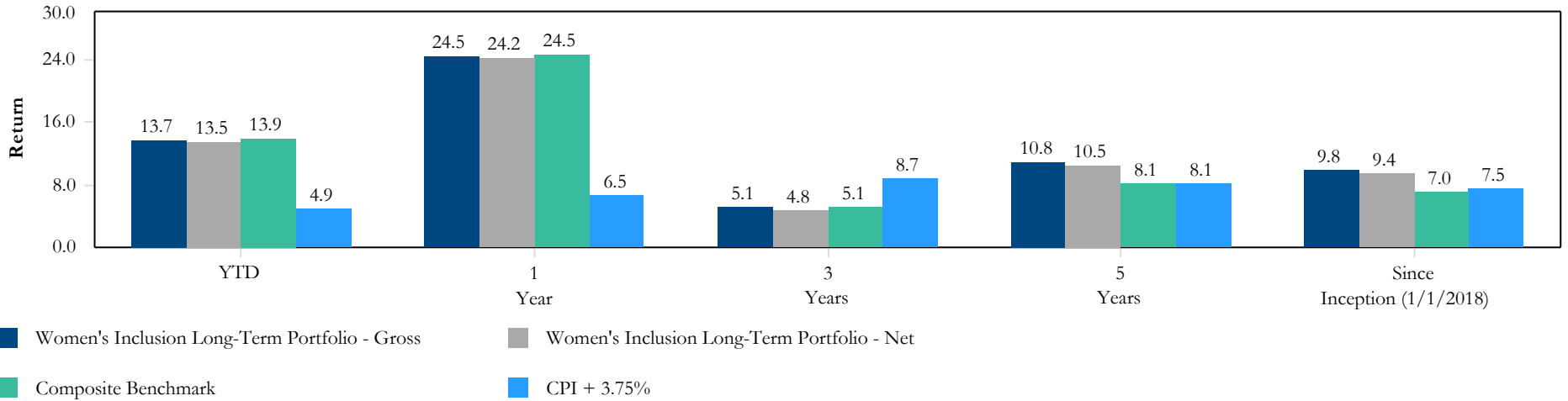


Socially Responsible Long Term Portfolio

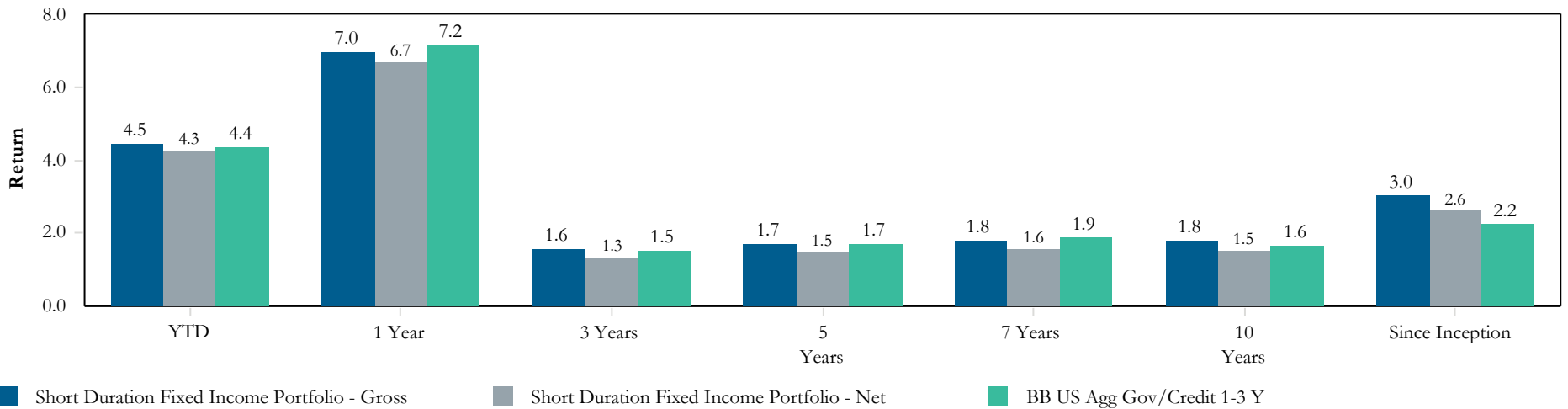
